## **OTICONGRESS CONDITIONS & INFORMATION**

- You will begin accumulating points on the first day of the month in which Oticon receives a completed OtiCongress Enrollment Form.
- You will accrue points for specific Oticon products as identified by Oticon, subject to change without notice. Demo instruments, Medicaid and possible third party entities are not eligible for point accrual. Points are kept in your account for a maximum of 18 months, after which the oldest month roll-off as the most recent month is added.
- You may accumulate points through the date specified for each OtiCongress
  event, typically 30-60 days prior to commencement of the event. If at the
  end of the accrual period you have not met the point requirement and you
  still decide to participate, your balance due amount will be calculated on
  \$4.00 (subject to change and without notice) for every whole point you are
  short meeting the point requirement. This balance can be paid by check or
  credit card. A balance due payment must be received prior to your departure
  and participation in the event.
- Trips include round trip airfare from a major US destination airport(s) of Oticon's choice, hotel accommodations and most meals. You are responsible for the U.S. domestic portion of air/ground travel (unless otherwise noted) and added cost due to flight upgrades, flight deviations and choice of carriers different from carriers contracted by Oticon. Points cannot be used towards the cost of domestic US travel and added cost due to flight upgrades, flight deviations and choice of carriers different from carriers contracted by Oticon unless specified in writing by Oticon. You are responsible for the cost of cancelled domestic airline tickets which have been issued including, but not limited to taxes, government, airline and travel agency fees whether a cancellation(s) were made by you, by Oticon or by Oticon's designated travel agency. You are also responsible for any airline change fee(s) and increased airfare(s) should you decide to change your itinerary after you have been ticketed. All U.S. domestic air/ground travel and added costs referred to in this paragraph must be paid for with check or credit card. All flights must be ticketed through Oticon's designated travel agency and no frequent flier miles may be used except for upgrades to the next class of service. Subject to availability and airline terms and conditions.
- Only Hearing Care Professionals (HCP) who are licensed or are registered in their individual states to dispense and fit hearing instruments are eligible to enroll and participate in the OtiCongress program and events. HCP may bring one guest utilizing available OtiCongress points. Non HCP but active employees of the business may also attend and use OtiCongress points only if an HCP is also attending. If an active employee brings a guest they must pay for this guest with a check or credit card (calculated at \$4.00 for every whole point needed.) Reservations are limited and Oticon reserves the right to limit participation for each account to two people (one room). Additional participation will be based on availability.
- Participation will also be based on meeting the minimum point requirement as specified for each OtiCongress event, subject to change. After that, participation will be based on sign-up date.
- Points can only be used to cover an individual who actively fit and dispense
  Oticon hearing instruments and one guest. Additional guests may attend,
  subject to availability, but must be paid for with cash or check.
- Points are nontransferable have no cash value. An account may not receive
  cash, credit or compensation of any kind in lieu of an OtiCongress event. This
  also applies to cancellations whether canceled by a participant's own choice
  or by Oticon.
- Travel dates are subject to change or cancellation if any unforeseen circumstances should arise.
- As an OtiCongress program participant you will be required to register online for an OtiCongress event. At some point after registering online you will be contacted by Oticon's designated travel agency to confirm your airline reservation and hotel accommodations. If you should make changes to the itinerary or cancel after this confirmation, you will be responsible for any additional costs, payment of non-refundable airline ticket(s), hotel deposits and all costs associated with you and your guest(s) portion of the trip unless

- covered by your total point accrual. If you travel outside the official published travel dates you are responsible for any additional costs incurred as this effects our contracted airline agreements. Such costs must be paid for by check or credit card only.
- Oticon reserves the right to make changes to the trips itinerary and program. In addition, in the event of a strike, lockout, riot, stoppage of labor from whatever causes, weather conditions, or for any other reason whatsoever, Oticon, Inc. may at its sole discretion, cancel, advance or postpone any part of the scheduled trips. Every attempt will be made to continue with the original schedule, but Oticon, Inc. is not liable for any loss whatsoever to the passengers by reason of such cancellation, advancement, postponement or substitution. Should an alternate or additional trip be offered, Oticon reserves the right to change the points required to qualify.
- All regulations of the airlines, tour groups and travel agencies apply.
- Oticon, Inc., its parent company or any of its affiliates will not be liable for injury to any persons or property arising from the means of transportation and other services used. We accept no responsibility for delays, missed connections, mechanical failures, lost or damaged luggage or mechanical failures of any nature caused by conditions beyond our control.
- Points are accrued by account, not by person, and may only be credited once.
   E.g., 1,650 points have been accumulated towards a specific OtiCongress event requiring 1625 points. Those points earn one free trip to the event for one person with 25 points carried over towards a second qualifying person or a future event.
- Point values assigned to hearing instruments and related dollar value are subject to change over time and without notice.
- Points can only be redeemed by qualifying participants with a current accounts receivable balance.
- Points are accumulated on net purchases. Qualifying instruments purchased during the qualification period, but returned for credit once the trip has been awarded are subject to a restocking fee of \$75.00 for each instrument, subject to change.
- Continuing education credits will be offered pending approval by the accrediting agencies.
- An account must maintain a minimum of 3 net average units per month
  of qualifying instruments in order not to forfeit accrued points. Average is
  based on most recent 6 months.
- Hearing instruments qualifying for points are subject to change and without notice.
- OtiCongress Conditions & Information are subject to change without notice.
- OtiCongress program may be discontinued with 30 day written notice.
- Oticon strongly recommends that all trip participants purchase travel insurance, e.g. trip cancellation, luggage insurance, etc.
- Oticon is not responsible for expenses incurred due to air/ground delays beyond the control of Oticon.
- As required by law a 1099-MISC (Miscellaneous Income) form will be issued to your corporate federal tax ID # or individual SS# based on your preference.
